## GAROFALO HEALTH CARE S.P.A.: TREASURY SHARE BUY-BACK ANNOUNCEMENT

**Rome, February 22, 2019** – Garofalo Health Care S.p.A. (the "**Company**" or "**GHC**"), listed on the MTA segment of the Italian Stock Exchange and an Italian accredited private healthcare leader (LEI code 815600C851C90CAE6438), with regards to the treasury share buy-back programme in service of the share incentive plans approved by the Company approved by the Shareholders' Meeting of September 26, 2018, whose launch was approved by the Board of Directors on January 29, 2019, as announced to the market on the same date as per Article 144-*bis* of Consob Regulation No. 11971/1999, announces that between February 18 and February 22, 2019, it acquired on the MTA segment of the Italian Stock Exchange 12,294 GHC shares (ISIN code: IT0005345233), equal to 0.01% of the share capital, at an average price of Euro 3.8669 per share, for a total of Euro 47,539.34.

The purchases were made through the intermediary Equita SIM S.p.A., LEI code 815600E3E9BFBC8FAA85.
