## GAROFALO HEALTH CARE S.P.A.: TREASURY SHARE BUY-BACK ANNOUNCEMENT

Rome, September 26, 2022 - Garofalo Health Care S.p.A. ("GHC"), listed on the Euronext STAR segment of the Italian Stock Exchange (LEI code 815600C851C90CAE6438), with regards to the treasury share buy-back programme authorized by the Shareholders' Meeting of April 29, 2022, as announced to the market on the same date as per Article 144-bis of Consob Regulation No. 11971/1999, announces that between September 19, 2022 and September 23, 2022, it acquired on the Euronext Milan segment of the Italian Stock Exchange 12,988 GHC shares (ISIN code: IT0005345233), equal to 0.01% of the share capital, at an average price of Euro 3.7502 per share, for a total of Euro 48,707.63.

The purchases were made through the intermediary Equita SIM S.p.A., LEI code 815600E3E9BFBC8FAA85.
