("GHC"), listed on the Euronext STAR Milan segment of Borsa Italiana, ahead of the Shareholders' Meeting called for April 28, 2023, discloses, pursuant to Article 85-bis, paragraph 4-bis of the Issuers' Regulations adopted by Consob with resolution No. 11971 of May 14, 1999 (the "Issuers' Regulations"), the total amount of voting rights, with an indication of the number of shares comprising the share capital, on the date referred to in art. 83-sexies, paragraph 2 of Legislative Decree No. 58 of February 24, 1998 (the so-called "record date").
