GAROFALO HEALTH CARE S.P.A.: TREASURY SHARE BUY-BACK ANNOUNCEMENT

Rome, January 20, 2025 - Garofalo Health Care S.p.A. ("**GHC**"), listed on the Euronext STAR segment of the Italian Stock Exchange (LEI code 815600C851C90CAE6438), with regards to the treasury share buyback programme authorized by the Shareholders' Meeting of April 29, 2024, as announced to the market on the same date as per Article 144-bis of Consob Regulation No. 11971/1999, announces that between January 13, 2025 and January 17, 2025 it acquired on the Euronext Milan segment of the Italian Stock Exchange 51,454 GHC shares (ISIN code: IT0005345233), equal to 0.06% of the share capital, at an average price of Euro 4.9876 per share, for a total of Euro 256,631.21.

The purchases were made through the intermediary Equita SIM S.p.A., LEI code 815600E3E9BFBC8FAA85.
